SPECIAL HORSE RULES

NOTE: This event is conducted under Peak Body Rules. All exhibitors must complete & sign an individual waiver form & compete at their OWN RISK. Bombala Show is governed by the ASC of NSW Rules for Discipline & Horse Welfare.

- **STRICTLY NO DOGS ALLOWED LOOSE ON THE GROUND AT ANY TIME**
- **ALL HORSE EXHIBITS** are required to be bitted in all rings, including in-hand, to keep ALL exhibitors safe.
- **INDEMNITY AND WAIVER FORMS:** Competitors taking part in the horse section of Bombala Show, do so at their own risk. Each adult competitor MUST, when entering via global entries, read and tick the acknowledgement box in the Global Entries on-line form, indemnifying the Bombala Exhibition Society Inc. and waiving any claims against the Society or its volunteers, for any injury sustained in competition, or for any loss or damage to the competitor's property or damage caused by the competitor or his/her animal (s).
- **On-line waivers MUST also be completed by a parent or guardian of each competitor under 18 years of age.** Each horse with which the competitor is involved in competition with at Bombala Show, must also be listed with the PIC number of the property from which the horse came from. **NO PIC, NO RIDE!**
- **Refusal of Entry/Alteration of Schedule:** The committee and stewards reserve the right to refuse an entry without assigning any reason and/or to alter or cancel the schedule to meet emerging circumstances.
- **Drug testing** may be carried out on the day/s of the competition in accordance with EA / FEI Veterinary Regulations and General Regulations. Compliance is mandatory to all exhibitors and persons responsible.
- **Height Measuring:** No official measuring will take place at the show, but, if a question about height arises, proof of height may be required. Any final decision will be at the absolute discretion of the Chief Steward.
- **Stable and Camping bookings via GLOBAL ENTRIES ONLY.** Covered horse stall fee \$10.00 / night . Open yard \$10/ night. **NON-POWERED** Camping \$10.00 / night per person pn. (Horses domiciled within 15 km of Bombala NA)
- **Show Hunters** cannot compete in the Open Hack Classes and vice versa. Applicable attire & gear applies.
- **Stable CLEANING DEPOSIT: All stables are to be left clean!** A \$50 deposit (refundable after stable inspections have been completed) is required to be paid via Global Entries, to secure a stable. NO exceptions!
- **Electric fencing must be erected in accordance with ASC NSW Construction Regulations.** No more than 16m² – 2 x strands must be energized. Allowable areas will be designated by the committee upon arrival &
- **EA Registration:** All EA Rules apply for the Show Jumping. Horse registration numbers must be included on Entry Form. Horse registration & grading card/s must be presented or no prize money will be awarded.
- **Jumping Rule:** A horse cannot jump anymore than 3 times per day or less, at the Judge's discretion.
- **Correct dress** regulations will apply to each ring. Helmets must be worn at all times when in jump areas.
- **Program Changes:** The organizing Committee reserves the right to alter the program if necessary.
- **Led riders** are not permitted in Hack Classes, unless the class is a stipulated 'led-line appropriate' class.
- **Event Draw:** Riders must follow the allocated draw or risk elimination from the event.
- **District Events:** Both horse and rider must reside in the 'OLD' Bombala Council area, as defined prior to SMRC council amalgamation, for a minimum of 30 days. Stewards/Committee may request proof of residence.
- **Novice Horse/Rider:** Not having placed first in an individual hack or riding class at any agricultural show
- **STALLIONS/COLTS:** Will NOT be allowed to compete in Open classes. Stallions/colts may only be shown in allocated Stallion classes, with the exception of specified Breed/Colour classes and show jumping events. STALLIONS/COLTS must be led or ridden by a person over 17 years, excepting the ASH 18 yrs & over rules.
- **The Judge's decision is final:** Official protest/s must be made in writing within ONE hour of the class being run and must be accompanied by a \$50 fee & presented directly to the Chief Horse Steward.
- **Consolation Classes:** Horse or rider has not placed or received a ribbon in a similar event at this show.
- **Safety Helmets:** All helmets must comply with current EA approved safety standards. Show Jumping competitors are required, as stipulated by EA in 2022, to have their helmet tagged by an accredited person.
